Re: FOIA Request – Records Related to May 9, 2018 Police Shooting of D'Quan Young on the 2300 block of 15th Street, Northeast, Washington D.C. 20002

Dear Freedom of Information Act Officer:

This is a request under the D.C. Freedom of Information Act ("FOIA"), D.C. Code § 2-531 et seq., on behalf of my client Cathy Young. Ms. Young seeks records related to a Metropolitan Police Department (MPD) officer's fatal shooting of her son, D'Quan Young, on May 9, 2018, at approximately 7:00 pm on the 2300 block of 15th Street N.E.

Pursuant to D.C. Code § 2-532, Ms. Young requests all records related to this incident, including, but not limited to:

- All records related to this incident that were provided to the Office of the District of Columbia Auditor, The Bromwich Group LLC, or Steptoe & Johnson LLP to support work on the March 23, 2021 report "The Metropolitan Police Department and the Use of Deadly Force: Four Case Studies 2018-2019";
- Any body-worn camera footage depicting the shooting of Mr. Young as well as any footage related to the shooting taken in the 20 minutes immediately before the shooting, in the 24-hours immediately after the shooting, or in the course of investigating the shooting;
- Any other camera footage or photographs of the shooting, the 20 minutes before the shooting, the two hours after the shooting, as well as camera footage or photographs taken as part of the investigation into the shooting. This request includes, but is not limited to, surveillance footage from cameras at the Brentwood Recreation Center or nearby D.C. Housing Authority facilities;
- Any copies of recordings or photographs that were enhanced by the Federal Bureau of Investigation (FBI) or other law enforcement entities, including but not limited to FBI enhancements of footage taken by the Brentwood Recreation Center cameras;
- Any records in MPD's possession documenting the findings of any investigations into this incident conducted by any government agency, including, but not limited to, MPD's Internal Affairs Division, MPD's Use of Force Review Board, the D.C. Office of Police Complaints, and the United States Attorney's Office for the District of Columbia;
- Any Decision Point Analysis Matrix prepared for this incident;
- Any medical and autopsy reports pertaining to the death of D'Quan Young;
- The crime scene examination report prepared for this incident;

- The final investigative report prepared for this incident;
- Any audio recordings and transcripts of investigative interviews pertaining to this incident;
- Any ballistic or forensic reports regarding the incident; and
- Any of the following types of reports about this incident: after-action reports, PD-251 forms, PD-76 forms, other incident reports, Citizen Complaint Reports (PD 99), OPC Complaint Forms (OPC 1), OPC Memoranda, and Preliminary Report Forms, (PD 901-a, or -b), Watch Commander's Reports (PD 150), Final Reports (MPD), and/or Officer Reports.

Ms. Young consents to the redaction of identifying information of any individuals other than MPD officers and her son. With this caveat, we believe that the requested records should be made public. No FOIA exemption applies here, as the investigation into this incident has finished and Ms. Young seeks records related only to the killing of her son, for whom she is next of kin. If you deem some or all of the records exempt, you must document the specific reasoning in writing and cite the applicable statutory exemptions. D.C. Code § 2-533(a). If a segregable portion of any record is not exempt, you must provide it and justify the decision not to provide the remainder. D.C Code § 2-534(b).

Because Ms. Young is next of kin to Mr. Young, the subject of the body-worn camera footage, her request for that footage constitutes a first-party request and she should receive it free of charge. As for the remaining records, Ms. Young requests a fee waiver. D.C. Code § 2-532(b) authorizes you to produce documents "without charge" when doing so "is in the public interest because furnishing the information can be considered as primarily benefiting the general public." Ms. Young will not gain commercially from these records. Rather, she seeks them for the solely so that her family and the community can evaluate MPD's actions in this case. The killing of D'Quan Young garnered significant public interest, as documented by extensive media coverage and the inclusion of this incident in the D.C. Auditor's March 2021 report. Disclosure will allow the public to understand and assess what occurred. Thus, a fee waiver should be granted.

If you determine no waiver is appropriate, and if the proposed fee is greater than \$25.00, we ask that you notify us prior to fulfilling the above requests.
