ABOUT THE ACLU OF THE DISTRICT OF COLUMBIA

Mission Statement

The American Civil Liberties Union of the District of Columbia (ACLU-D.C.) works with District residents and supporters of our vision to protect and advance civil liberties and civil rights by using the tools of public education, political advocacy, and litigation.

Vision Statement

We envision a just and free D.C. where all people, especially historically oppressed communities, live without systemic governmental oppression and can exercise their power to protect and expand civil rights, civil liberties, and human dignity

Q: Can I hold a fundraiser for the ACLU-D.C.?

A: Yes! Please let us know of your plans by writing info@acludc.org.

Q: Can ACLU-D.C. partner with, co-sponsor, or promote my event?

We will do our best to support your event but may not have the capacity to accommodate all requests. Please email info@acludc.org at least three weeks prior to your event with your event details. We will review and respond to your request. We cannot provide a monetary co-sponsorship or sponsorship.

Q: May I use the ACLU-D.C. logo and name on my event?

A: You may indicate that your event is to benefit ACLU-D.C., however, you may not use our logo in any promotional content. Its use is reserved for events produced by the ACLU-D.C.

Q: Can a representative from ACLU-D.C. attend and/or speak at my event?

A: While we cannot promise to fulfill every request, we will consider requests for ACLU-D.C. representation at third-party events. Participation depends on staff availability as well as the event being aligned with our mission and advocacy objectives. If you'd like to request an ACLU-D.C. representative at your event, please fill out this form at least three weeks prior to your event. We will do our best to accommodate your request.

FREQUENTLY ASKED QUESTIONS

Q: Can ACLU-D.C. provide me with “swag” – promotional items and giveaways – for my event, i.e. buttons, stickers, posters, magnets, etc.?

A: The ACLU has a distribution company that handles all promotional items. There are a variety of items that can be purchased at the ACLU shop (<https://shop.aclu.org>). We may be able to provide limited materials. Please let us know of your plans by writing info@acludc.org at least three weeks prior to the event.

Q: What is the difference between making a tax-deductible donation to the ACLU-D.C. Foundation and becoming a member of the ACLU-D.C.?

Gifts to the ACLU-D.C. Foundation, our 501(c) (3) entity, support our litigation, communications, advocacy, and public education efforts. These donations are tax-deductible. Contributions to our 501(c)(4) entity, ACLU-D.C. Union, allow us the greatest flexibility in our work. While not tax-deductible, they enable us to advocate and lobby in legislatures to advance civil liberties. They also support our litigation, communications, advocacy, and public education efforts. Contributions to the Union make you an ACLU member.

Q: May I use the ACLU-D.C. logo and name on my event?
