

District Voters Overwhelmingly Support Revised Criminal Code Act

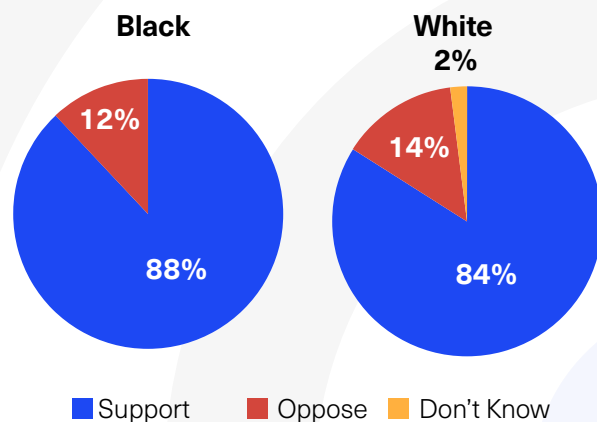


The Revised Criminal Code Act of 2021 (RCCA), legislation that would update nearly all the District’s criminal code provisions, is making its way through the DC Council. The bill establishes proportionality and consistency in sentencing while modernizing outdated parts of our code. DC Justice Lab and FWD.us commissioned HIT Strategies to conduct a poll on the subject, finding that 83% of District voters support the bill after being given a three-sentence description. 79% are more likely to support a candidate who would vote for the RCCA. An overwhelming majority of voters—across races and ages, genders, and Wards in the District—support this legislation and its individual provisions.



Washingtonians overwhelmingly support criminal justice reform.

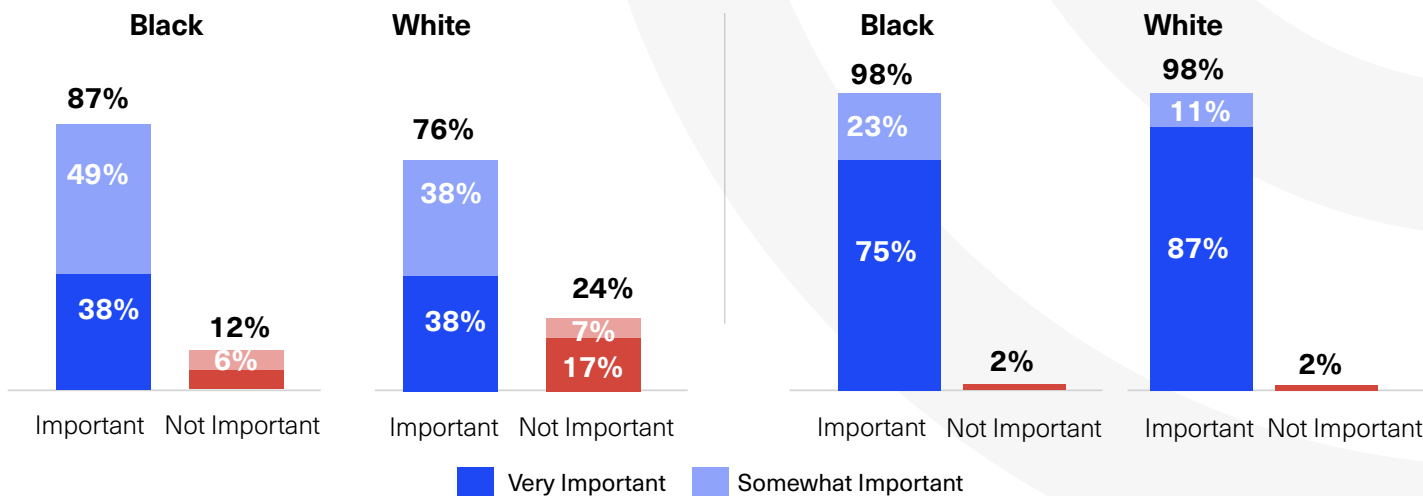
Generally speaking, do you support criminal justice reform in the District of Columbia?

How important do you believe it is to ensure fairness and consistency in the District’s criminal laws?



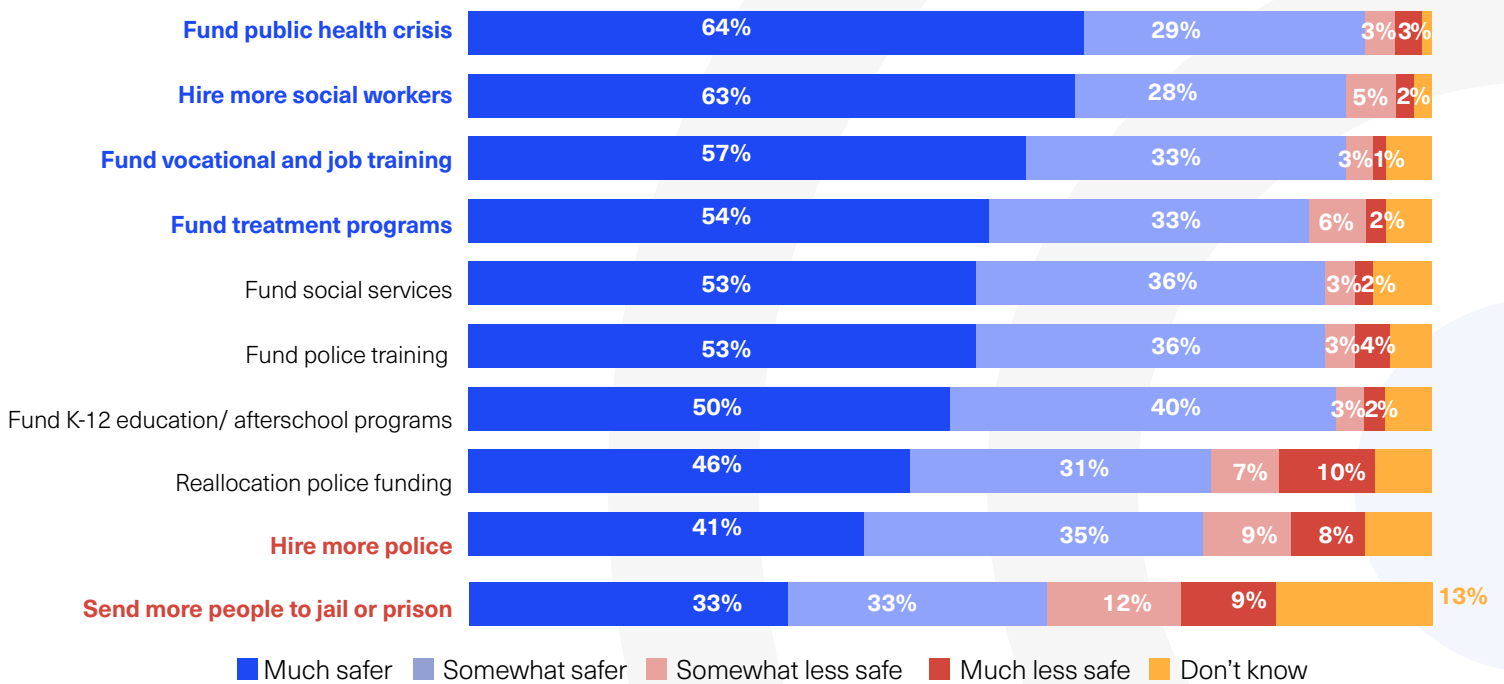

DC voters strongly prefer investments in social services and treatment programs to tough on crime policies.

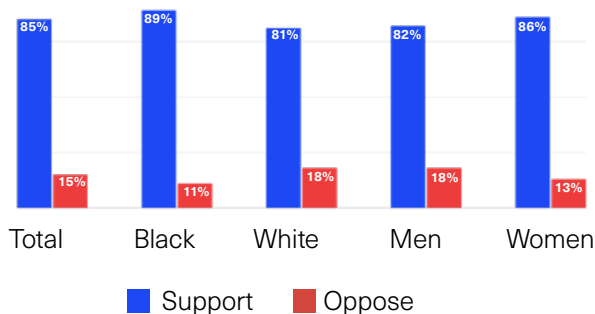


Please state whether the following would make you feel much safer, somewhat safer, somewhat less safe, or much less safe.



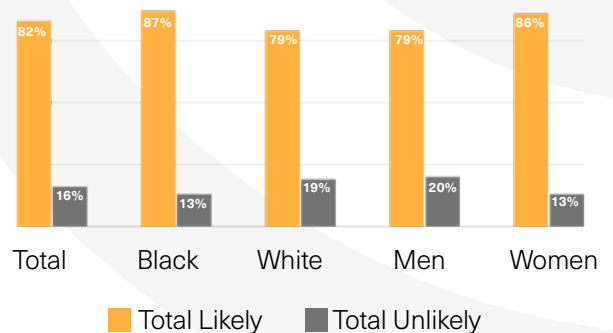
Support for RCCA remained high after exposure to both pro- and anti-RCCA messages.

How likely are you to support a candidate who would vote in favor of the Revised Criminal Code Act (RCCA)?

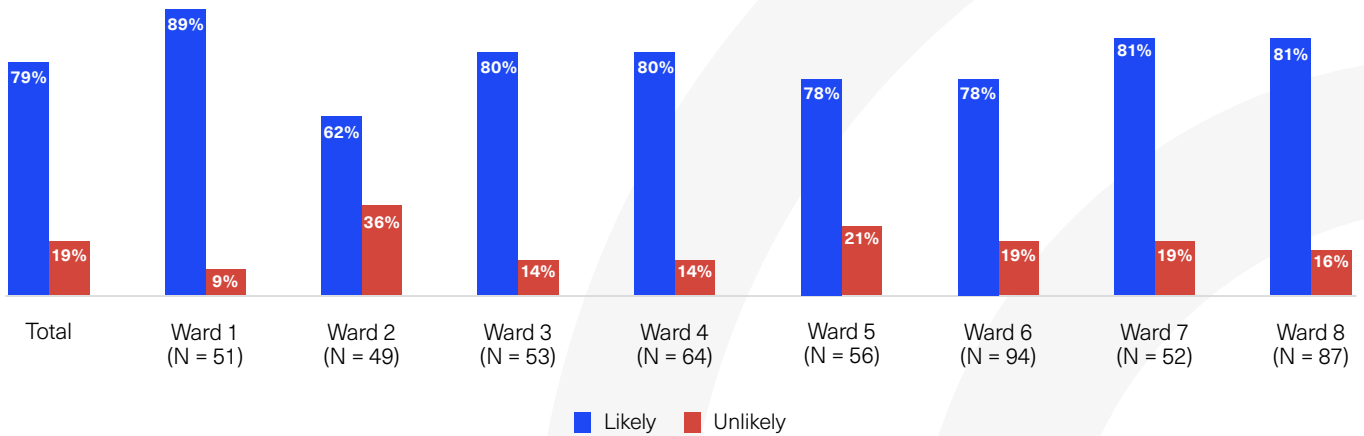

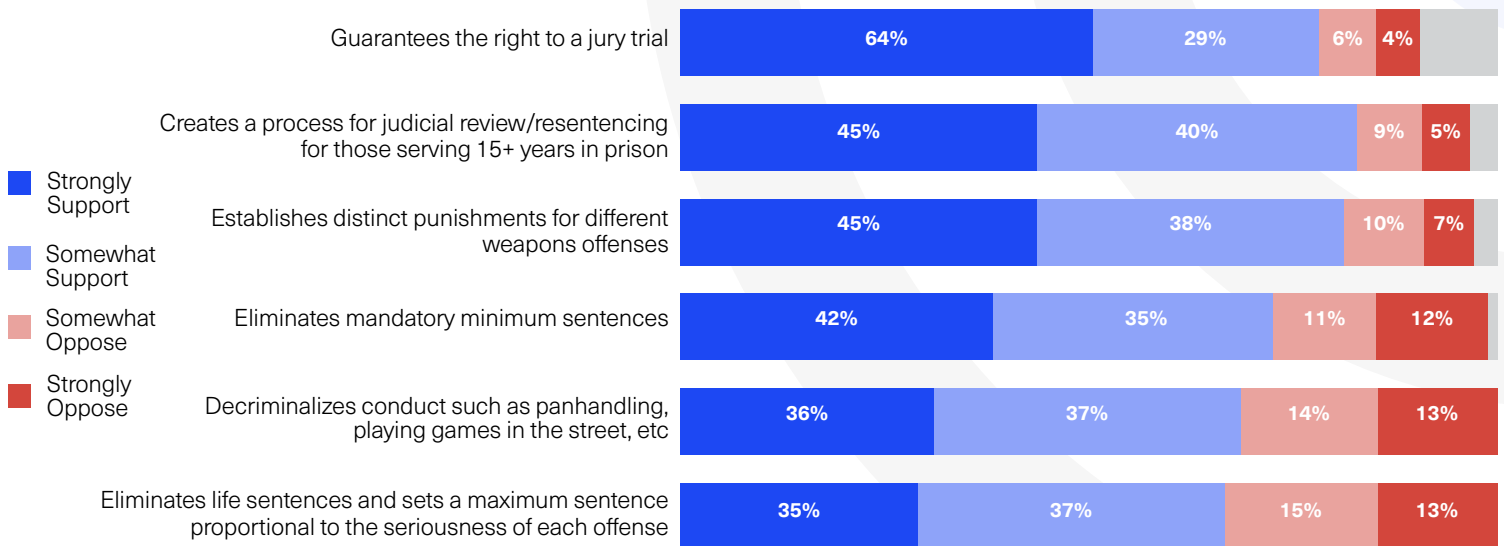
Washingtonians' support for pro-RCCA candidates is high across Wards.

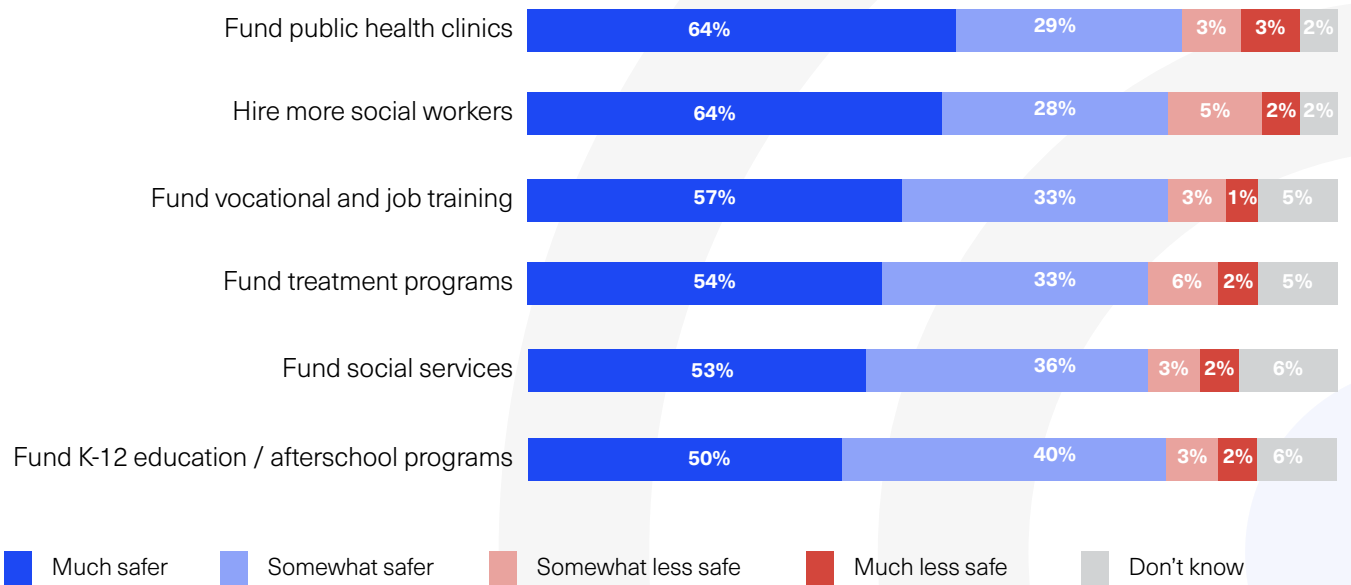
